#### A. INSTRUCTIONS

- You **MUST** include a 10.00 fee for each badge application.
- If you are requesting a Provisional (Temporary) Badge, you must also include a \$10.00 Provisional Badge Fee. \*Primary Game Operators are **not eligible** for Temporary Badges\*
