BINGO AND LUCKY 7 GAMES - DISTRIBUTOR BOND**

KNOW ALL MEN BY THESE PRESENTS:

as SURETY, are held and firmly bound unto the New Hampshire Lottery Commission and to any person who may have a cause of action against the Principal for any liabilities arising out of the conduct of business by the Principal as a Bingo/Lucky 7 Distributor, in the sum of \_\_\_\_\_ (\$ \_\_\_\_\_) lawful money of the United States of America, to be paid to the New Hampshire Lottery Commission for the use of the New Hampshire Lottery Commission, and to any person who may have a cause of action against the Principal for any such liabilities in the conduct of Bingo/Lucky 7 Distributing by the Principal as their interests may appear, not exceeding in the aggregate the same sum of \_\_\_\_\_ (\$ \_\_\_\_\_) for which payment will truly be made we bind ourselves, our heirs, executors, administrators, successors and assigns, jointly and severally by these presents.

Whereas, the above bounden Principal has applied to the New Hampshire Lottery Commission for a Bingo/Lucky 7 Distributor license.

Now the condition of this obligation is such that if the New Hampshire Lottery Commission license the above bounden Principal and said Principal shall faithfully and honestly act as such in accordance with the law, and fully complies with the provisions NH RSA 287-E and other amendments thereto and if the Principal shall fully indemnify and save harmless from loss the New Hampshire Lottery Commission and any person who may have a cause of action against the Principal for any liabilities arising out of the conduct of business as such Bingo/Lucky 7 Distributor, then this obligation to be void, otherwise to remain in full force and effect.

This Bond shall not become void upon the first recovery thereon but may be executed upon from time to time until the full amount thereof shall have been exhausted. Regardless of the number of years this bond remains in force, the aggregate liability of the Surety for any and all claims shall in no event exceed the penal sum of the bond.

The term of this bond shall run annually from fiscal year to fiscal year, to be effective on July 1st, \_\_\_\_\_ and terminate on June 30th, \_\_\_\_\_. This obligation may be continued from year to year by a continuation certificate.

The surety reserves the right to withdraw except as to any liability already incurred or accrued hereunder, and may do so upon giving written notice of the withdrawal to the New Hampshire Lottery Commission at 14 Integra Drive, Concord, NH 03301. Withdrawal shall not be effective until sixty (60) days have elapsed after receipt of the notice by the Commission. Withdrawal shall not affect the surety's liability arising out of any outstanding amount incurred prior to the expiration of the 60-day period.

This bond is to cover all claims arising on account of the registration of the Principal and his/her acting employees, agents, Bingo/Lucky 7 Distributors or representatives for the full term hereof beginning on the date of said registration and for one year thereafter.
