- will ensure that only individuals who have not been convicted of a felony within the previous 10 years, or a misdemeanor involving falsehood or dishonesty within the past 5 years, which have not been annulled by a court, or have violated any of the statutes or rules governing gambling in the past in this or any other state will be allowed to participate in the operation of charitable gaming.

I further certify, under penalty of unsworn falsification pursuant to RSA 641:3, that the information provided on this form and on any of the supporting documentation submitted with this application is true, accurate and complete, and that there are no willful misrepresentations in, or falsifications of the information provided herein. I acknowledge that giving false information is grounds for denial, suspension, or revocation of a gaming license.

INSTRUCTIONS FOR COMPLETING THE MONTHLY BINGO/LUCKY 7 LICENSE APPLICATION FORM

A. WHEN TO USE THIS FORM

A charitable organization must submit a “*Charitable Organization Eligibility Determination Application*” prior to or in conjunction with this license application form. A license will not be issued until the organization is deemed eligible to participate in charitable gaming.

A charitable organization must complete this form when it will be:

- Operating a Bingo event (with or without offering Lucky 7 ticket for sale); or
- Selling Lucky 7 tickets at a Games of Chance Facility.

If Lucky 7 will be sold at the organizations meeting place (such as the bar of a social club), or at an annual event sponsored by the charitable organization, use the “*License Application-Lucky 7 Only*” form.

B. LICENSING FEE

Please include the following payment based on your selection in section 2:

- Bingo & Lucky 7 – payment of \$25.00 per bingo game date plus a \$10.00 lucky 7 license fee.
- Bingo (No Lucky 7) – payment of \$25.00 per bingo game date.
- Lucky 7 at GOC – payment of a \$10.00 lucky 7 license fee.

Checks and or money orders must be made payable to “NH LOTTERY COMMISSION”.

C. SUBMITTING THE FORM

This application form must be received by the New Hampshire Lottery Commission at least 15-days, but no more than 45-days prior to the organizations first proposed bingo and/or lucky 7 game date.

Applications that are incomplete, illegible or do not include correct fee payments will be returned to the applicant, which will delay the processing of this application.

If at any time information provided on or with the form changes or is found to be inaccurate, the applicant must submit updated or corrected information to the NH Lottery, Investigation & Compliance Division within 10 days of the event that resulted in the change, or discovery of the inaccuracy.
