BINGO LOT RULE OF THE MONTH:

Lot 7003.04(a) – States that no individual or entity, other than a charitable organization or governmental subdivision, shall lease or rent premises for the conduct of bingo without a commercial hall license issued by the commission.

LUCKY 7 LOT RULE OF THE MONTH:

Lot 7105.04(a) – States that if a seal card game contains a separate information sheet that describes additional play instructions, then the information sheet shall be publicly posted next to its accompanying seal card.

GAMES OF CHANCE LOT RULE OF THE MONTH:

Lot 7206.07(d) – States that a licensee shall obtain the NH Lottery Commission's approval whenever a modification is made to an approved game procedure, including any changes made to the odds.



BINGO / LUCKY 7

HB1245 - LUCKY 7 TICKET PRICES

On July 29, 2020, Governor Sununu signed HB1245 into law. This legislation includes language (provided below) that increases the price of a Lucky 7 ticket to \$0.50 and \$1.00. This change took effect on July 29, 2020.



RSA 287-E:20, II. The price of any lucky 7 ticket pack or ticket card shall be either \$0.50 or \$1.00, provided that at any location where a charitable organization offers \$1.00 tickets for sale the charitable organization shall also offer \$0.50 tickets for sale.

GAMES OF CHANCE (GOC)

GAMES OF CHANCE APPLICATIONS

Anyone (charitable organization or operator) who needs to renew a license or obtain a new games of chance license <u>MUST</u> submit the following documents to the NH Lottery Commission:

- A correctly completed application charitable organization, secondary game operator, primary game operator, game operator employer or GOC facility – along with all supporting documentation.
- A signed and notarized Criminal Record Release Authorization Form (form can be found on our website at: https://www.racing.nh.gov/licensing/games-chance/documents/chrirequest-form.pdf).
- A money order or check for the license fee made payable to: NH Lottery Commission Please <u>DO NOT</u> include a \$10.00 temporary badge fee with this total. We are not issuing temporary badges right now due to fingerprinting locations not being open.
- Please <u>DO NOT</u> send payment for State Police or proof of fingerprinting at this time.

When all documents are received and in order, the NH Lottery licensing unit will issue a license which will be contingent upon the individual completing fingerprinting requirements at a future time.

Within 30-days of the termination of the State of Emergency - Executive Order, each applicant MUST complete the fingerprinting requirement (ink card or livescan site form) of the criminal record check. Once the applicant has had their prints taken, all proof of fingerprinting documents will then need to be submitted to the NH Lottery Commission, along with a check or money order in the amount of \$48.25 (made payable to: State of NH - Criminal Records). If an applicant does not meet the 30-day deadline, their license will expire on the 31st day.

Upon receipt of the criminal history results, the NH Lottery licensing unit will either (1) grant full license status for the remainder of the license period for applicants with a clean criminal history, or (2) deem the license expired for all applicants whose criminal history disqualify them for licensure. All applicants that are subsequently denied a license may appeal the decision as permitted by RSA 541–A.


