BINGO LOT RULE OF THE MONTH:

Lot 7004.04(1)(4) - Licensed charitable organizations shall have the purchase of bingo paper supplies and electronic bingo player systems, including copies of invoices provided by the distributor.

LUCKY 7 LOT RULE OF THE MONTH:

Lot 7104.02(c) - Neither the manufacturer, nor any of its employees, shall participate in the lucky 7 games it provides to its customers in New Hampshire.

GAMES OF CHANCE LOT RULE OF THE MONTH:

Lot 7206.02(a) - A games of chance licensee shall only conduct games of chance that have been identified on a game schedule, and approved by the commission.

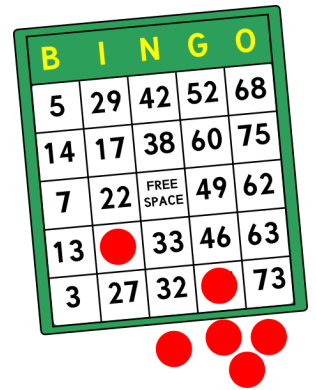

RENTAL PAYMENT - MONTHLY FINANCIAL REPORTS

RSA 287-D:19, II(d) says that the charity's share of the revenue after prizes and rent is paid cannot be less than zero. This means that at the end of the month, the charity can never owe any money to the game operator employer. For example, if the charity's portion of the revenue is \$400.00 before rent is paid, and the rent is \$750.00, the charity does not owe the game operator employer the remaining rent of \$350.00 because it would violate RSA 287-D:19, II(d).

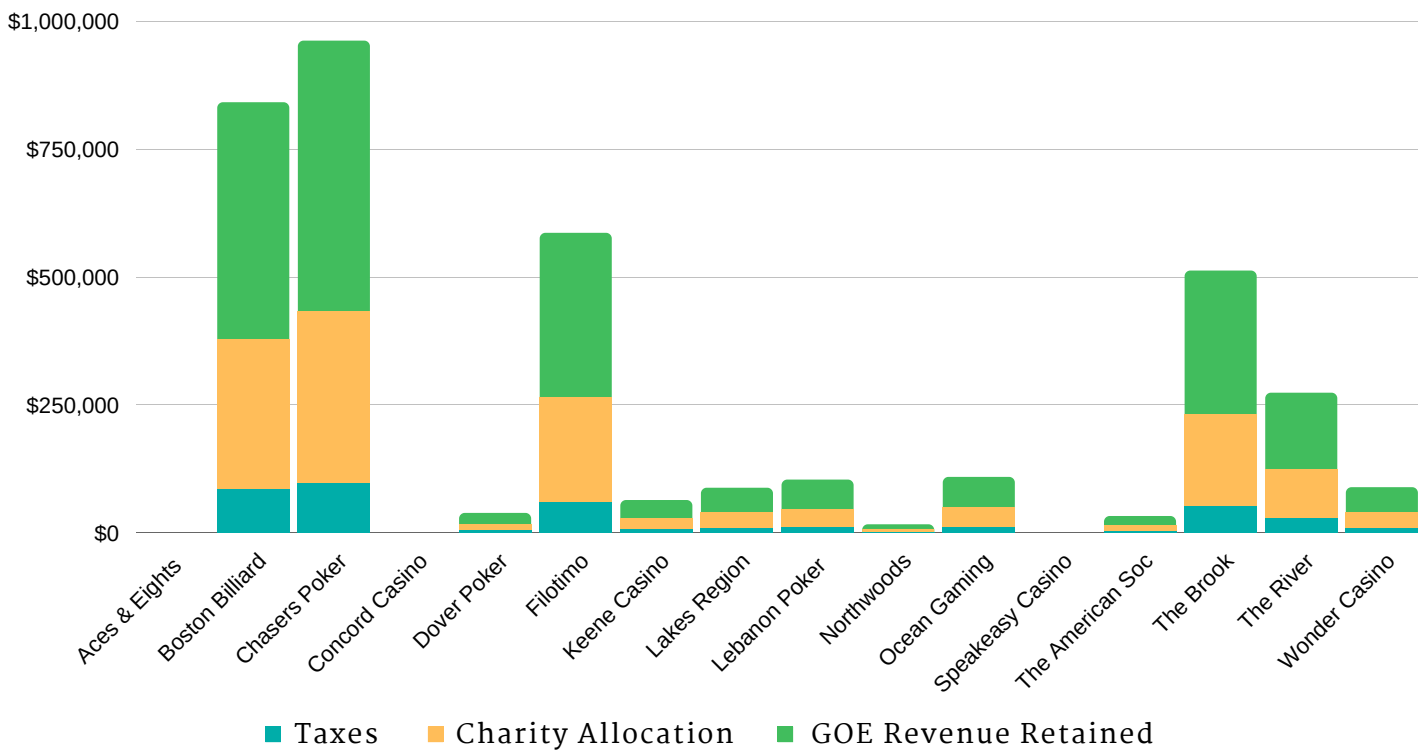
