## BINGO PARI RULE OF THE MONTH:

Pari 1007.03(g)(5) - States that cardminding devices shall allow the player to cancel or correct any numbers entered in error when the device requires the player to manually enter ball call numbers.

## LUCKY 7 PARI RULE OF THE MONTH:

Pari 1106.01(a) – States that a charitable organization shall submit lucky 7 house rules to the commission with its application for licensure, and at any time thereafter when a change to the house rules is being made.

### GAMES OF CHANCE LOT RULE OF THE MONTH:

Lot 7206.04(a)(1) - States that all agreements between a charitable organization and a game operator employer shall be enacted using the "Standard Form of Agreement for Games of Chance" form.


### **CREDITS/REFUNDS DUE TO COVID-19 PANDEMIC**

Due to the COVID-19 pandemic, multiple organizations were unable to use a few or all of the game dates they had scheduled for charitable gaming.

Once the emergency order is lifted, the commission would like to give all the affected organizations the option to either receive a credit <u>or</u> a refund for the unused game dates. Game operator employers (GOE) should be working with their organizations to determine which option is best for them. Key items to remember:

- If the organization wants a refund for the unused game dates, please note that refunds can take a few weeks to process.
- If the organization wants a credit for the unused game dates, the credits will need to be used during their current license period.
- The commission will not be able to process credits until we have received the signed letter stating that they would like a credit back from the organization.
- If the organization chooses to receive a credit but the GOE is unable to issue new game dates before their license expires, the organization will automatically receive a refund.

## STATE TAX, CHARITY ALLOCATION & GOE REVENUE RETAINED APRIL 2018-SEPTEMBER 2019




