INSTRUCTIONS FOR COMPLETING A GAMES OF CHANCE (GOC) PRIMARY/SECONDARY GAME OPERATOR RENEWAL

A. DETERMINING IF A NEW APPLICATION IS REQUIRED

Licenses expire 3 years after being issued, provided that the licensee shall annually file a "Games of Chance (GOC) PGO/SGO Renewal" form, by the last day of their birth month.

The licensee shall immediately notify the commission in the event the licensee is subject to arrest or conviction of any criminal offense.

PGO/SGO Licenses expire on the last day of the applicant's birth month.

B. LICENSE FEE

Include a payment of:

- \$100.00 for a Primary Game Operator or
- \$30.00 for a Secondary Game Operator.
